Each Cochrane Clinical Answer contains a clinical question, a short answer, and an opportunity to 'drill down' to the evidence from relevant Cochrane reviews. The evidence is displayed in a user friendly format, mixing narrative, numbers and graphics. The taraet audience for Cochrane Clinical healthcare Answers is

practitioners and informed health care decision-makers.

Based on the high-quality Cochrane evidence of systematic reviews, this clinical support tool provides evidencebased answers when and where they are needed the most, makina it to find easv authoritative answers to clinical Cochrane auestions. # CNCF receives special mention in American Journal of Nursing

The American Journal of Nursing (AJN) recently published an article discussing Cochrane reviews and the significance of CNCF review summaries.

Published on 1 May 2015 and written by Amanda Anderson, a Critical Care Nurse and Graduate Student in New York City, the article refers to the difficulty in trying to find credible evidence for bedside nurses that is uncomplicated and easy to implement. The article suggests that most of the reliable evidence available for nurses can be quite lengthy to read, and requires a depth of analysis and understanding in the topic area. The writer then goes on to talk about the Cochrane Collaboration and how its reviews can be considered a 'bedside quide' for nurses. She refers to a recent 'Cochrane Corner' publication in the AJN and how this article changed her view on a method of practice, and helped her to see things are not always as 'black and white' as nurses and related healthcare practitioners might immediately assume based on historical practices. Ultimately the writer suggests that Cochrane reviews, and review summaries, provide a current and reliable evidence basis on which alternate practices can be considered and

developed by those working on the front line in a hospital setting. #### Loss of one of Cochrane's founders



It is with great sadness that Cochrane announces the death of its founding chair and medical pioneer, Dr. David Sackett. He was 80 years old.

Born in Chicago, Illinois, Dave Sackett was an originator of clinical epidemiology and evidence-based medicine and the first chair of the Cochrane Collaboration Steering Group in 1993. He founded the first department of Clinical Epidemiology and Biostatistics in the world, at McMaster University in Hamilton, Ontario, in 1967 and founded the Oxford Centre for





Evidence-Based Medicine in the UK in 1994.

Dave's contributions to Cochrane's work date from the earliest days of the organization and have made a substantial impact on its development and reputation over the past two decades.

Dave's colleagues at McMaster plan and Cochrane commemorate his contribution to evidence-based medicine in various ways, including The Dave Research Sackett Symposia during the 23rd Cochrane Colloquium in Vienna in October 2015.
