Cochrane Review Tagging Work

The CNCF has begun tagging Cochrane reviews that are relevant to nursing care. Initially we are focusing on reviews completed in the last 18 months and have tagged relevant reviews using a two-tiered





system: by their primary specialty and their fundamental of care. The aim of this work is to facilitate better access to Cochrane Reviews to nurses and those involved in nursing care

Revman 5 Update

Revman is the software used for preparing and maintaining Cochrane Reviews.

RevMan 5.1 has now been released and minor revisions to the Cochrane Handbook for Systematic Reviews of Interventions (Version 5.1.0, March 2011) have been made. Although there are no plans to reissue the Wiley book, all other formats are available in the revised version.

The main changes are a modification of the Risk of bias tool, and the new ability to draw PRISMA-style study flow diagrams.
